Dear Senator Ward,

I am writing on behalf of Lincoln University in my Senate District, the first degreegranting Historically Black College and University (HBCU) in the nation and one that continues to serve more than 1,800 graduate and undergraduate students each year.

Like its state-related counterparts, Pennsylvania State University, Temple University, and the University of Pittsburgh, Lincoln continues to await its annual state-related budget appropriation. These funds, which have been held up since the summer, represent approximately 20 percent of Lincoln's operating budget.

As students are now nearly midway through the fall semester, the continued delay in delivering this vital funding threatens to negatively impact nearly every aspect of life on Lincoln's campus. Students and families who are already shouldering increased consumer costs face an uncertain future in managing tuition and other necessary expenses. More than 100 faculty and staff now face a hiring freeze with furloughs on the horizon later this month.

With limited cash on hand, Lincoln University leaders are searching for ways to meet their responsibility to educate and empower students. However, the ongoing fiscal stalemate is now jeopardizing student life, learning, and Lincoln's vision to be a national model for both 21st-century liberal arts undergraduate education and innovative graduate and professional programs.

In light of these growing challenges and concerns, I respectfully encourage Senate Majority Leadership to call House Bill 1461 for a vote immediately or offer some other funding mechanism or avenue to provide this necessary support. While I understand that this year's budget negotiation process, like most, had its share of partisan disputes, we must move forward in the spirit of bipartisanship for students and families across the Commonwealth. I stand ready to assist in any way possible.

Lastly, I must note that unlike the other state-related colleges and universities, Lincoln faces its own unique challenges as a smaller, semi-private, liberal arts and historically Black institution. As a result, the negative impact of holding up this appropriation is especially felt by its students, faculty, and campus.
